Dear Tribal Health Leaders

On behalf of the Department of Health (the department) and in keeping with the responsibility to conduct tribal consultation, I am writing to inform you of a proposed Medicaid state plan amendment (SPA) and Alternative Benefit Plan amendment. This opportunity for consultation runs concurrently with the public comment period on proposed regulations.

Purpose and content of the proposed amendment:

The department proposes to amend both the Medicaid State Plan and Alternative Benefit Plan to exempt hospitals that are reimbursed based on the Diagnosis Related Groups (DRG) payment rate methodology from continued stay authorization requirements.

The department also proposes to add 1915(K) Community First Choice services to the Alternative Benefit Plan to align with the Medicaid State Plan. There are no changes to coverage or reimbursement. This amendment does not have an anticipated impact on Medicaid-eligible Alaska Native/American Indian beneficiaries or tribal health programs and the Indian Health Service.

Anticipated impact on Medicaid-eligible Alaska Native/American Indian beneficiaries:

The department anticipates the amendments exempting hospitals that are reimbursed based on the DRG payment rate methodology from continued stay authorization requirements will positively impact all Medicaid beneficiaries by reducing administrative barriers to covered services.

Anticipated impact on tribal health programs and the Indian Health Service:

The department does not anticipate the amendments exempting continued stay authorizations will have a direct impact on tribal health programs. Only those facilities that are reimbursed based on DRG payment rate methodology are impacted; to date, no tribal health programs have elected to receive payment based on DRG payment rate methodology. The proposed amendments will benefit relevant hospitals by reducing administrative burden.
